

Working to Open New States



We ran bills to open up 4 of the 5 closed states in 2019, and we will be doing so again in 2020.









Working to Remove Capacity Caps



We are in the midst of a multi-year effort to remove the 250,000-gallon capacity caps in New Jersey and Ohio

Our partnership with FreeTheGrapes is absolutely crucial to our success in these states.

Working to remove the exclusion for those wineries who have a wholesaler in Indiana



Working to Remove On-Site Restrictions



Working to remove the on-site sales requirement in both Arkansas and Rhode Island

Working to pass effective DTC permit laws with tax payment and reasonable reporting provisions in Alaska and Minnesota

delivery practices.




Working to prevent anti-carrier language from being adopted.



Common Carrier Licensure & Reporting Requirements for DTC Wine Shipments





Requires Licensure Requires Reporting

Requires records to be retained & submitted upon request

Addressing Concerns about "Delivery" vs. "Shipping"



As states work to license and/or regulate "delivery" apps, we are working to ensure that they don't inadvertently have a negative impact on "shipping" via OREGON common carrier















Working to Address State Enforcement Concerns



Out-of-State Wine Retailer Shipments Allowed in 15 States and DC: AK, CT, DC, FL, ID, LA, NE, NV, NH, NM, ND, OR, VA, WV, WY
